I. State: Gujarat

Agenda 1. Diversion of 39.00 ha Reserved forest land for Port and Terminal as well as other allied activities in the adjoining forest land falling towards sea side (west side) having forest survey no 605 (old No. 302/A/1/B) in connected in favour of General Manager (Terminal), Gujarat Chemical Port & Terminal Company LTD. , Baruch District of Gujarat. Therefore, the question is whether this compliance report from the MP Govt can be considered favorably and Stage-II approval granted by REC in its meeting proposed to be held on 30/07/2015.
